- c. 2013 budget—Discussion regarding a small increase to the HOA assessment by \$1 making it \$40 a month. The assessment has not been raised for several years and a small increase will help to keep up with the increase in irrigation water rates.
- d. 2012 overseeding for winter rye grass—Board has unanimously voted not to overseed the park this winter in order to maintain an every other year schedule so that summer Bermuda is healthy and the association can conserve water use funds.
- e. Burns Pest Control—The board has agreed to do a major spraying twice a year to take care of scorpions and other critters. This will add an additional \$600 per year to the cost of our regular monthly service.
