### **Board of Directors - Open Meeting Minutes**

I. Call to Order. The meeting was called to order at 7:00 PM: With Lisa Juarez, Marie Spillett, Paul Krey; Peri Swenson and Bill Collier from Kinney Management in attendance. Absent: Tyler Dixon.

II. Review and Approval of Meeting Minutes dated March 4, 2015. (Unanimous approval)

# III. Treasures Report:

- Review of Income Statements dated February 28, 2015 and March 31, 2015. Discussed various items and noted 100 large trees were trimmed and expense was posted to the income statement. (Unanimous acceptance)
- Invoice approvals none presented.

# IV. Old Business / Follow-up discussion:

- Exterior home paint project status letters were mailed out based on the inspection previously
  made. Another group of homes will be looked at in the fall and thereafter as scheduled until the
  entire community has been reviewed. A question arose about a Lot on Weldon Ave and Bill will
  research for the board. Also it was noted that a Lot on Weldon only painted the trim of their home.
- Reminder comment Corner homes need their block fence wall painted when their home is painted.
- Mailbox repairs/Base painting or replacement: Goodyear Post Office has confirmed that they will
  replace the mailbox bases and not paint. Post Office will advise when work is scheduled. Tentatively
  they hope to get it done in the fall or as soon as they can schedule it.
- The financial compilation work by the CPA firm is under way.
- Peri stated the dog waste stations have been ordered.

#### V. New Business:

The board requested that Luis evaluate the common areas and map out tree and shrub stumps that
need to be removed. A proposal should be prepared for removing them. A second proposal to fill in
the gaps from missing trees, shrubs and plants should also be prepared by Luis at Somerset
Landscaping.

#### VI. Projects:

- Play equipment repairs and replacement was briefly discussed but tabled until the fall.
- Sand for tot lot bids were presented for rototill and replacement of sand. A motion was made and seconded to accept the RDC bid and add an amount to allow for 5-10 tons of new sand if needed (Appx \$200 to \$400). Motion accepted unanimously.
- Broken ramada roof tiles Discussed, Frank no longer has a roofer available so we need to request new bids for the job.
- Peri gave an update on new signage and will call Luis to see if all the new signs have been put up. It
  was stated that a new sign was needed south of 143<sup>rd</sup> and Weldon in the breezeway.
