New Legislation

Below is a summary of some important 2004 Arizona legislation regarding community associations. A majority of the new laws (unless specifically noted) went into effect on August 25, 2005.

Open Meetings: Association members shall be permitted to attend and speak at an appropriate time during deliberations and proceedings of all meetings of the association and the Board of Directors. The Board may place reasonable time restrictions and shall provide for a reasonable number of persons to speak on each side of an issue.

Annual Audit: The Board shall provide for an annual financial audit, review or compiliation of the association. It shall be completed no later than 180 days after the end of the fiscal year and shall be made available upon request to homeowners. (Effective January 1, 2005)

Political Signs: An association shall not prohibit the outdoor display of a political sign by an association member on his/her lot, 45 days before an election and 7 days after. The association can regulate the size and number of signs.

Car Safety Seat Inspections

Arizona law requires that any child under the age of 5 years must be in a child restraint when in a vehicle. Remember to keep your children buckled up and away from the airbags of the vehicle.

Certain police and fire personnel have received special training to become Certified Car Safety Technicians. These technicians will be happy to inspect and install your child safety seat at no cost to you. New car seats are sometimes available through a grant from the Governor's Office of Highway Safety.

To learn how to install your child safety seat, you may contact the police department, or you may schedule an appointment through the Fire Department.

It Takes A Community...

There is great concern among residents regarding activities of the younger individuals in the community. Complaints range from vandalism to throwing rocks, resulting in damage to homeowner property. These activities are costing your community money, as the clean up and repair can be expensive. As a community, please advise children of the concerns and keep an eye out for criminal activity. Homeowners that witness this type of behavior are advised to call the Goodyear Police Department at (623) 932-1220.

Alterations To Your Property

Approvals must be given prior to improvements or alterations to property for things such as adding structures to backyards, ornamental items in front yards and/or making changes to your approved front yard land-scaping.

The Sunrise at Wigwam CC&R's require that homeowners obtain the prior approval of the Design Review Committee for ANY exterior alteration or addition to their property.

If you would like to submit for approval of any exterior alteration or addition, please call the management company for an Architectural Review Form.

Parking Concerns

Parking on the street presents two main concerns. Firstly, it is a safety hazard. There are children within our community who, although they shouldn't, sometimes play or run into the street. None of us would ever forgive ourselves should an accident occur due to restricted visibility from one of our vehicles being parked in the street.

Secondly, it is unsightly. Streets lined with vehicles detract from the overall aesthetic appeal of our neighborhood and create a negative initial impact on prospective buyers. Homebuyers view many different communities before coming to their decision on which home to purchase. On-street parking is definitely becoming a factor effecting the buyer's decision.

In the pursuit of preserving appeal and safety within our neighborhood, and preserving the property value for you when you come to sell your home, we ask that you please park all vehicles in your driveway or garage at all times.
